

# MARYLAND READY MIX CONCRETE ASSOCIATION (MRMCA)

## *Scholarship Program Description*

2009

### **I. POLICY PURPOSE**

The MRMCA scholarship (currently in the amount up to \$2,000 annually) is being established to provide an educational opportunity for one or more qualified students who desire a career in the concrete or construction industry (depending on availability of funding).

### **II. POLICY STATEMENT**

This is an annual scholarship to be awarded to a Maryland high school graduate who is accepted for enrollment at any of the participating Community Colleges or Universities with a major in Concrete or Construction Management or related degree. Preference will be given to a dependent of a MRMCA member company or an employee of a MRMCA member firm. The MRMCA also encourages participation from member companies to provide matching scholarship funds.

### **III. POLICY PROVISIONS**

- A. The scholarship will be awarded annually by MRMCA. Students must apply each year.
- B. Payment will be made directly to the school in the award winner's name.
- C. The MRMCA Scholarship Committee will be responsible for the review of all applications and for the selection of the recipient.

### **IV. ELIGIBILITY**

The scholarship will be awarded to the eligible individual who meets the following criteria at the time of the award. The student must:

- A. Exhibit high school (and/or college) grades, courses taken, and ACT/SAT scores that would indicate the likelihood of being admitted to college and being successful in a Concrete or Construction Management Program or related degree. Consideration will be given to all applicants who apply and will be judged versus the relative merit versus other applicants.
- B. Be active in high school or community groups.
- C. Exhibit a strong interest in pursuing a career in the construction industry.
- D. Major in Concrete or Construction Management or related degree.
- E. Applicants must be residents of Maryland. Preference will be given to employees and dependents of employees of MRMCA member companies.

### **V. APPLICATION PROCESS**

- A. Applications and accompanying materials must be submitted to the MRMCA by May 1. Scholarship will be awarded by June 1 for the following school year.
- B. Applications will be available at the MRMCA office and will be distributed to MRMCA members yearly.
- C. The scholarship recipient will be notified by June 15 and results published to all member companies.
- D. A completed application form must be submitted by the candidate, accompanied by at least two letters of reference and an essay by the applicant regarding his/her desire for this scholarship and interest in the concrete or construction industry.

### **VI. FUNDING SOURCES**

MRMCA will use sponsorships and other events to fund the scholarship program.
